THIS AGREEMENT is made on2022

BETWEEN:

- 1. **BORDEAUX UK HOLDINGS II LIMITED**, a private limited company incorporated in England and Wales with registered number 10959617 whose registered office is at c/o Moorcrofts LLP Thames House, Mere Park, Dedmere Road, Marlow, Buckinghamshire, England, SL7 1PB ("**Bidco**"); and
- EMIS GROUP PLC, a public limited company incorporated in England and Wales with registered number 06553923 whose registered office is at Fulford Grange Micklefield Lane, Rawdon, Leeds, England, LS19 6BA ("EMIS")

(each a "party" and together the "parties").

WHEREAS:

- (A) Bidco, an affiliate of Optum Health Solutions (UK) Limited ("Optum UK") and a whollyowned subsidiary of UnitedHealth Group Incorporated ("UnitedHealth Group"), proposes, immediately following execution of this Agreement, to announce a firm intention to make a recommended offer for the entire issued and to be issued share capital of EMIS (the "Acquisition") on the terms and subject to the conditions set out in the Announcement (as defined below).
- (B) The parties intend that the Acquisition will be implemented by way of a scheme of arrangement of EMIS under Part 26 of the Companies Act 2006 (the "Scheme"), provided that Bidco reserves the right as set out in (and subject to the terms and conditions of) the Announcement and this Agreement, to elect to implement the Acquisition by way a contractual takeover offer as defined in Chapter 3 of Part 28 of the Companies Act 2006 (the "Offer).
- (C) The parties wish to enter into this Agreement to record their respective obligations relating to the Acquisition.

THE PARTIES AGREE as follows:

1. Interpretation

1.1 In this Agreement each of the following words and expressions shall have the following meanings:

"Acceptance Condition"	means, if applicable, the acceptance condition to the Offer as specified in clause 6.2(A);
"Acquisition"	has the meaning given to it in recital (A);
"Agreed Switch"	means where the Acquisition is implemented by way of an Offer in accordance with: (i) clause 6.1(A); (ii) clause 6.1(B); or (iii) clause 6.1(E), in each case circumstances

where the EMIS Board Recommendation is given in respect of that Offer;

- "AIM" means AIM, a market operated by the London Stock Exchange;
- "AIM Rules" means the rules of AIM as set out in the "AIM Rules for Companies" issued by the London Stock Exchange from time to time relating to AIM traded securities and the operation of AIM;
- "Announcement" means the announcement to be released by Bidco and EMIS pursuant to Rule 2.7 of the Code in relation to the Acquisition, substantially in the form set out in Schedule 2 (Form of Announcement);
- "Antitrust Remedies" means in respect of the CMA Condition, any conditions, obligations, measures, commitments, disposals, divestitures, modifications, undertakings, licenses of intellectual property, remedies or assurances (financial or otherwise) required or necessary to ensure the satisfaction of the CMA Condition, and "Antitrust Remedy" shall be construed accordingly in each instance;
- "Bidco Directors" means the directors of Bidco from time to time, and "Bidco Director" shall be construed accordingly;

"Bidco Group" means Bidco and its subsidiaries and subsidiary undertakings from time to time and "member of the Bidco Group" shall be construed accordingly;

- "Business Day" means any day, other than a Saturday or a Sunday or a public holiday in England and Wales or New York, when banks are generally open in London and New York for general banking business;
- "Clearances" means all approvals, consents, clearances, permissions, confirmations, comfort letters and waivers that may need to be obtained or are advisable, and all filings that may need to be made or are advisable and all waiting periods that may need to have expired, from or under any of the Laws, regulations or practices applied by any Relevant Authority (or under any agreement or arrangements to which any Relevant Authority is a party), in each case that are necessary or advisable to enable the Effective Date to occur by the Long Stop Date and/or to satisfy one or more of the Regulatory Conditions; and any reference to any Clearance having been "**satisfied**" shall be construed as

meaning that the foregoing has been obtained or, where relevant, made or expired;

- "CMA Condition" means the Condition set out in paragraph 3(a) of Appendix 1 to the Announcement;
- "Code" means the City Code on Takeovers and Mergers as issued from time to time by or on behalf of the Panel;
- "**Companies Act**" means the Companies Act 2006, as amended from time to time;
- "Competing Proposal" means:
 - an offer (including a partial, exchange or tender (a) offer), merger, acquisition, dual-listed structure, scheme of arrangement, reverse takeover, and/or whitewash transaction business combination (or the announcement of a possible offer or firm intention to make an offer), the purpose of which is to acquire, directly or indirectly, 30 per cent. or more of the issued and to be issued ordinary share capital of EMIS (when aggregated with the shares already held by the acquirer and any person acting or deemed to be acting in concert with the acquirer) or any arrangements or series of arrangements which results in any party acquiring, consolidating or increasing "control" (as defined in the Code) of EMIS;
 - (b) the acquisition (or the announcement of a proposed acquisition), directly or indirectly, of all or a significant proportion of the business, assets and/or undertakings of the EMIS Group calculated by reference to any of its revenue, profits or value taken as a whole;
 - (c) a demerger, any material reorganisation and/or liquidation (or proposed demerger, material reorganisation and/or liquidation) involving all or a significant proportion of the EMIS Group calculated by reference to any of its revenue, profits or value taken as a whole; or
 - (d) any other transaction undertaken (or the announcement of a possible transaction) without Bidco's consent which would be substantially

alternative to, or inconsistent with, or would otherwise be reasonably likely materially to preclude, impede or delay or otherwise prejudice the implementation of the Acquisition (including, for the avoidance of doubt, any transaction or arrangement which would constitute a reverse takeover for the purposes of the AIM Rules undertaken by EMIS),

in each case which is not effected (or proposed to be effected) by Bidco (or a person acting in concert with Bidco) nor at the direction of or with the written agreement of Bidco, and in each case whether implemented (or proposed to be implemented) in a single transaction or a series of transactions and whether conditional or otherwise;

"Conditions"

means:

- (a) for so long as the Acquisition is being implemented by means of the Scheme, the terms and conditions to the implementation of the Acquisition as set out in Appendix 1 to the Announcement, as may be amended by Bidco with the consent of the Panel and EMIS; and
- (b) for so long as the Acquisition is being implemented by means of an Offer, the terms and conditions referred to in paragraph (a) above, as amended by replacing the Scheme Conditions with the Acceptance Condition, and as may be further amended by Bidco with the consent of the Panel and EMIS,

and "Condition" shall be construed accordingly;

- "Confidentialitymeans the confidentiality agreement entered into betweenAgreement"Optum Health Solutions (UK) Limited and EMIS in relation
to the Acquisition dated 8 April 2022;
- "**Consideration**" has the meaning given to it in the Announcement;
- "Court" means the High Court of Justice in England and Wales;
- "Disclosing Party" has the meaning given to it in clause 3.7;

"Effective Date" means the date upon which either:

- (a) the Scheme becomes effective in accordance with its terms; or
- (b) if Bidco elects to implement the Acquisition by means of an Offer, the Offer becomes or is declared unconditional in all respects;

"EMIS Board" means the board of directors of EMIS from time to time;

- (a) if EMIS makes an announcement prior to the publication of the Scheme Document or (if different) the document convening the EMIS General Meeting that: (i) the EMIS Board no longer intends to make the EMIS Board Recommendation or intends to adversely modify or qualify such recommendation; (ii) other than where a Switch has occurred, it will not, or does not intend to, convene the EMIS Court Meeting or the EMIS General Meeting; or (iii) other than where a Switch has occurred, it will not, or does not intend to, post the Scheme Document or (if different) the document convening the EMIS General Meeting;
- (b) the EMIS Court Meeting and/or the EMIS General Meeting is adjourned, or not held on the expected date of such meeting as set out in the Scheme Document (or EMIS makes an announcement that it will delay the convening of, or will adjourn, the EMIS Court Meeting and/or the EMIS General Meeting), in each case without the consent of Bidco (except where such adjournment, or failure to so hold the relevant meeting, is for force majeure reasons);

- (d) the EMIS Board withdraws or adversely modifies or qualifies the EMIS Board Recommendation including making any public statements to such effect (or makes an announcement that it intends to do so);

- "EMIS Group" means EMIS and its subsidiaries and subsidiary undertakings from time to time and "member of the EMIS Group" shall be construed accordingly;
- "EMIS Resolutions" means such shareholder resolutions of EMIS as are necessary to approve, implement and effect the Scheme and the Acquisition and the changes to EMIS's articles of association contemplated in the Announcement, at either

- "EMIS Shareholders" means the registered holders of EMIS Shares from time to time;
- "EMIS Shares" means the ordinary shares of 1 pence each in the capital of EMIS from time to time;

- "Law" means any applicable statutes, common law, rules, ordinances, regulations, codes, orders, judgments, injunctions, writs, decrees, directives, governmental guidelines or interpretations having the force of law or bylaws, in each case, of a Relevant Authority;
- "London Stock means London Stock Exchange plc or its successor;

"Long Stop Date" means 30 June 2023 or such later date as Bidco and EMIS may, with the consent of the Panel, agree and, if required, as the Court may approve;

"**Notice**" shall have the meaning given to it in clause 13.1;

- "Offer" shall have the meaning given to it in recital (B), and reference to "Offer" shall include any increased, renewed or revised offer;
- "Offer Document" means, in the event that Bidco elects to implement the Acquisition by means of the Offer in accordance with clause 6, the document setting out (among other things) details of the Acquisition and the full terms and conditions of the Offer to be sent to (among others) the EMIS Shareholders, including any revised or supplementary offer document;
- "**Optum UK**" has the meaning given to it in recital (A);

"Optum UK Group"	means Optum UK and its subsidiaries and subsidiary undertakings from time to time and " member of the Optum UK Group " shall be construed accordingly;
"Panel"	means the UK Panel on Takeovers and Mergers;
"Permitted Dividends"	has the meaning given to it in the Announcement;
"Permitted Final Dividend"	has the meaning given to it in the Announcement;
"Permitted Interim Dividend"	has the meaning given to it in the Announcement;
"Regulatory Conditions"	means the Conditions set out in paragraphs 3(a) and (b) and 4(a) to (c) of Appendix 1 to the Announcement;
"Regulatory Information Service"	means a regulated information service as defined in the FCA Handbook;
"Relevant Authority"	means any central bank, ministry, governmental, quasi- governmental, supranational (including, for the avoidance of doubt, the European Union), statutory, regulatory, environmental, administrative, supervisory, fiscal or investigative body or authority (including any national or supranational anti-trust, competition or merger control authority, any sectoral ministry or regulator and any foreign investment review body), national, state, municipal or local government (including any subdivision, court, tribunal, administrative agency or commission or other authority thereof), any entity owned or controlled by them, any private body exercising any regulatory, taxing, importing or other authority, trade agency, association, institution or professional or environmental body in any jurisdiction, including, for the avoidance of doubt, (i) the Panel, (ii) the Financial Conduct Authority, (iii) the UK Competition and Markets Authority and (iv) the Investment Security Unit of the Department for Business, Energy and Industrial Strategy of the UK Government, and " Relevant Authorities " means all of them;
"Sanction Hearing"	means the hearing of the Court to sanction the Scheme under section 899 of the Companies Act, including any adjournment thereof

adjournment thereof;

- "Scheme" has the meaning given to it in recital (B), and reference to "Scheme" also includes any modified, renewed or revised Scheme;
- "Scheme Conditions" means the Conditions relating to the Scheme becoming effective in accordance with its terms, as set out in paragraphs 2(a) to (c) of Appendix 1 to the Announcement;
- "Scheme Document" means the circular to be sent to (among others) EMIS Shareholders setting out (among other things) details of the Acquisition, the full terms and conditions of the Scheme and the explanatory statement required pursuant to Part 26 of the Companies Act and incorporating the notices convening the EMIS Court Meeting and the EMIS General Meeting, including any revised or supplementary circular;
- "Scheme Shareholders" means the holders of Scheme Shares;
- "Scheme Shares" has the meaning given to it in the Announcement;
- "Switch" has the meaning given to it in clause 6.1;
- "UnitedHealth Group" has the meaning given to it in recital (A);
- "Wider Optum Group" means UnitedHealth Group and its subsidiaries, subsidiary undertakings and associated undertakings, and any other undertaking (including any joint venture, partnership, firm or company) in which UnitedHealth Group and/or any such undertakings (aggregating their interests) have an interest of more than 20 per cent. of the voting rights or equity share capital of such undertaking; and
- "Working Hours" means 9.30 a.m. to 5.30 p.m. in the relevant location on a Business Day.
- 1.2 In this Agreement, except where the context otherwise requires:
 - (A) references to recitals, clauses, paragraphs or Schedules are to recitals to, clauses and paragraphs of and Schedules to this Agreement;
 - (B) the expressions "**subsidiary**" and "**subsidiary undertaking**" shall have the meanings given in the Companies Act;
 - (C) the expression "**group**" in relation to a party, means that party together with its subsidiaries and subsidiary undertakings from time to time;

- (D) the expressions "**acting in concert**", "**control**" and "**offer**" shall have the meanings given in the Code and the expression "**takeover offer**" shall have the meaning given in section 974 of the Companies Act;
- (E) use of any gender includes the other genders;
- (F) words in the singular shall include the plural and vice versa;
- (G) a reference to any statute or statutory provision shall be construed as a reference to the same as it may have been, or may from time to time be, amended, modified, replaced or re-enacted and shall include any subordinate legislation made from time to time under that statute or statutory provision;
- (H) references to a "company" shall be construed so as to include any, corporation or other body corporate, wherever and however incorporated or established;
- (I) references to a "person" shall be construed so as to include any individual, firm, company, corporation, body corporate, government, state or agency of a state, local or municipal authority or government body or any joint venture, association or partnership (whether or not having separate legal personality);
- (J) any reference to a "**day**" (including the phrase "**Business D**ay") shall mean a period of 24 hours running from midnight to midnight;
- (K) references to times are to London time;
- (L) references to "£", "**pounds sterling**", "**pence**" and "**p**" are to the lawful currency from time to time of the United Kingdom;
- (M) references to any English legal term for any action, remedy, method of judicial proceeding, legal document, legal status, court, official or any legal concept or thing shall in respect of any jurisdiction other than England be deemed to include what most nearly approximates the English legal term in that jurisdiction;
- (N) references to "writing" shall include any modes of reproducing words in any legible form and shall include email except where otherwise expressly stated;
- (O) a reference to "**includes**" or "**including**" shall mean "includes without limitation" or "including without limitation", respectively;
- (P) the rule known as the *ejusdem generis* rule shall not apply and accordingly general words introduced by the word "other" shall not be given a restrictive meaning by reason of the fact that they are preceded by words indicating a particular class of acts, matters or things;
- (Q) general words shall not be given a restrictive meaning by reason of the fact that they are followed by particular examples intended to be embraced by the general words;

- (R) a reference to any other document referred to in this Agreement is a reference to that other document as amended, varied, or supplemented at any time; and
- (S) references to this Agreement include this Agreement as amended or supplemented in accordance with its terms.
- 1.3 The headings in this Agreement are for convenience only and shall not affect the interpretation of this Agreement.
- 1.4 The Schedules form part of this Agreement and shall have the same force and effect as if expressly set out in the body of this Agreement, and any reference to this Agreement shall include the Schedules;

2. Publication of the Announcement and the terms of the Acquisition

- 2.1 The obligations of the parties under this Agreement, other than the Initial Provisions, shall be conditional on the release of the Announcement via a Regulatory Information Service on the date of this Agreement, or such later date as the parties may agree (and, where required by the Code, the Panel may approve). The Initial Provisions shall take effect on and from execution of this Agreement.
- 2.2 The terms of the Acquisition shall be as set out in the Announcement, together with such other terms as may be agreed by the parties in writing (save in the case of an improvement to the terms of the Acquisition, which will be at the sole and absolute discretion of Bidco) and, where required by the Code, approved by the Panel.
- 2.3 The terms of the Acquisition at the date of posting of the Scheme Document shall be set out in the Scheme Document. Should Bidco elect to implement the Acquisition by way of an Offer in accordance with clause 6, the terms of the Acquisition shall be set out in the announcement made in accordance with paragraph 8 of Appendix 7 of the Code of the Switch and in the Offer Document.

3. Regulatory Clearances

- 3.1 Bidco shall use all reasonable endeavours to secure the Clearances as soon as reasonably practicable following the date of this Agreement and in any event in sufficient time to enable the Effective Date to occur prior to the Long Stop Date.
- 3.2 Without prejudice to the generality of clause 3.1, Bidco shall submit to the Relevant Authorities (in draft or in final form, as the case may be) any filings, notifications or submissions as are necessary or advisable in connection with the Clearances which it has a responsibility to make under applicable Law (or if otherwise required by a Relevant Authority), including for the avoidance of doubt a briefing paper to the UK Competition and Markets Authority, as soon as reasonably practicable after the date of this Agreement and within any applicable mandatory time periods.
- 3.3 Notwithstanding any other provision of this Agreement, in respect of the CMA Condition, Bidco acknowledges and agrees that its obligation pursuant to clause 3.1 shall include

offering, agreeing, accepting and executing (and/or, if applicable, causing the offer, agreement, acceptance and/or execution of) any Antitrust Remedies that are required or necessary to ensure satisfaction of the CMA Condition as soon as reasonably practicable following the date of this Agreement and, in any event, in sufficient time to enable the Effective Date to occur by the Long Stop Date, unless doing so would, taking such Antitrust Remedies together in aggregate, reasonably be expected to result in a material adverse effect on the business, operations, or financial condition of the Optum UK Group, together with the EMIS Group following implementation of the Acquisition.

- 3.4 Except where otherwise required by applicable Law or a Relevant Authority, Bidco shall:
 - (A) after prior consultation with EMIS and taking into account its reasonable comments and suggestions, determine the strategy for obtaining the Clearances, including the timing and sequencing for contacting and corresponding with the Relevant Authorities (and, if applicable, the strategy for offering or accepting any remedies (including any Antitrust Remedies) that may be required, as a basis for, or by, any Relevant Authority to give its Clearance);
 - (B) promptly contact and correspond with the Relevant Authority in relation to the Clearances; and
 - (C) be responsible for the payment of all filing fees required in connection with the Clearances.
- 3.5 Save to the extent prohibited by applicable Law or a Relevant Authority, EMIS undertakes to Bidco to:
 - (A) provide as soon as reasonably practicable, and in any event, to the extent reasonably practicable, well in advance of any deadline or due date imposed by applicable Law:
 - all such information as may reasonably be required to determine in which jurisdictions any merger control, regulatory or other similar filing, notification or submission to a Relevant Authority may be necessary or advisable for the purposes of obtaining the Clearances that are necessary to satisfy one or more of the Regulatory Conditions;
 - (ii) all such information as may reasonably be required for inclusion in any filings, notifications or submissions to any Relevant Authority for the purposes of obtaining the Clearances that are necessary to satisfy one or more of the Regulatory Conditions or for inclusion in any responses to any requests for further information consequent upon such filings, notifications or submissions; and
 - (iii) all such other assistance as may reasonably be required, including assistance in connection with such pre-notification contacts with any Relevant Authorities as may be necessary or advisable, for the purposes

of obtaining the Clearances that are necessary to satisfy one or more of the Regulatory Conditions; and

- (B) provide as soon as reasonably practicable, in consultation with Bidco, such information and access to EMIS management and employees as Bidco or any Relevant Authority may reasonably require in connection with any filing, notification or submission to any Relevant Authority for the purposes of obtaining the Clearances that are necessary to satisfy one or more of the Regulatory Conditions.
- 3.6 Save to the extent prohibited by applicable Law or a Relevant Authority, Bidco undertakes to EMIS to:
 - (A) as soon as reasonably practicable provide, or procure the provision of, to EMIS (and its legal advisers) copies of all filings, notifications, submissions, material correspondence and material communications submitted, sent or communicated to any Relevant Authority for the purposes of obtaining any Clearance (including, in the case of material non-written correspondence or communications, reasonable summaries of such correspondence or communications);
 - (B) as soon as reasonably practicable, notify EMIS (and its legal advisers) of, and provide copies of, any material correspondence and material communications (including, in the case of material non-written correspondence or communications, reasonable summaries of such correspondence or communications) received from any Relevant Authority in connection with obtaining the Clearances;
 - (C) to the extent practicable, provide EMIS (and its legal advisers) with draft copies of all material written communications (unless administrative in nature) intended to be sent to any Relevant Authority in connection with obtaining any Clearance, at such time as will allow EMIS a reasonable opportunity to comment on them, and have regard in good faith to any reasonable comments which EMIS may have in relation to any such draft copies of such communication;
 - (D) give EMIS (and its legal advisers) reasonable notice of any meetings, hearings or scheduled telephone calls (unless administrative in nature) with any Relevant Authority relating to the relevant Clearance and, if appropriate, allow EMIS (and its legal advisers) (i) a reasonable opportunity to attend or otherwise participate in any such material meetings, hearings or telephone calls (unless prohibited by the Relevant Authority or applicable Law) and (ii) to make oral submissions at any such material meetings, hearings or telephone calls (provided such oral submissions have been discussed by the parties in advance); and
 - (E) keep EMIS (and its legal advisers) informed as soon as reasonably practicable of developments which are material or potentially material to obtaining of any of the Clearances.

- 3.7 If any provision of this Agreement obliges Bidco or EMIS (the "**Disclosing Party**") to disclose any information to the other:
 - (A) that is personally identifiable information of a beneficial owner, director, partner, officer or employee of the Disclosing Party or any member of its group or any of their respective affiliates, unless that information can reasonably be anonymised (in which case, the Disclosing Party shall provide the relevant information on an anonymous basis);
 - (B) which the Disclosing Party reasonably considers to be commercially or competitively sensitive;
 - (C) which the Disclosing Party is prohibited from disclosing by applicable Law or the terms of an existing contract; or
 - (D) where such disclosure would result in the loss of privilege that subsists in relation to such information (including legal professional privilege),

the Disclosing Party shall, to the extent permitted by applicable Law, disclose the relevant information to the other party:

- (i) (to the extent necessary) pursuant to any clean team arrangements as may be agreed between the parties from time to time;
- (ii) on an "outside counsel" basis; or
- (iii) where disclosure to the other party would reasonably be expected to have a material adverse effect on the Disclosing Party's legitimate business interest, directly to a Relevant Authority (and in such circumstances, the Disclosing Party shall provide, or procure the provision of, a non-confidential version of such information to the other party) but provided always that nothing in this Agreement shall oblige the Disclosing Party to disclose any information where such disclosure would result in the loss of privilege that subsists in relation to such information (including legal professional privilege).
- 3.8 Except with the prior written consent of EMIS (such consent not to be unreasonably withheld, conditioned or delayed), Bidco shall not, and shall procure that each member of the Bidco Group shall not, directly or indirectly:
 - (A) take, or cause to be taken, any action; or
 - (B) enter into any acquisition, transaction or other agreement,

in either case, which would, or would be reasonably expected to, have the effect of precluding or materially delaying the satisfaction of the Regulatory Conditions.

4. Scheme Document

- 4.1 Bidco agrees:
 - (A) promptly, to provide to EMIS all such information about itself, the Bidco Directors, the Wider Optum Group or any other person acting in concert with Bidco (including any information required by the Code or under other applicable Law, including in relation to the intentions of Bidco) as may be reasonably requested and which is required by EMIS and/or its legal advisers, having regard to the Code and other applicable Law, for inclusion in the Scheme Document;
 - (B) promptly, to provide all such other assistance and access as may be reasonably required in connection with the preparation of the Scheme Document and any other document required by the Code or other applicable Law to be published in connection with the Scheme, including access to, and procuring that reasonable assistance is provided by, its professional advisers; and
 - (C) to procure that the Bidco Directors (and any other person connected with Bidco or the Wider Optum Group, as required by the Panel) accept responsibility, in the terms required by the Code, for all the information in the Scheme Document, and any other document required by the Code or other applicable Law to be published in connection with the Scheme, relating to:
 - themselves (and their close relatives (as defined in the Code), related trusts and companies and other persons connected with them), the Wider Optum Group and Bidco's concert parties and the financing of the Acquisition;
 - (ii) information on Bidco's future plans for the EMIS Group and its business, places of business, management and employees and pension schemes;
 - (iii) any statements of the opinion, belief, intention or expectation of Bidco or the Bidco Directors in relation to the Acquisition or the EMIS Group following the completion of the Acquisition; and
 - (iv) any other information in the Scheme Document for which a bidder and/or its directors are required to accept responsibility under the Code or other applicable Law.
- 4.2 Bidco shall allow EMIS reasonable opportunity to provide comments on any announcement or communication to EMIS shareholders, employees and option holders in connection with the Acquisition, and shall take into account EMIS's reasonable comments on such announcement or communication, in each case to the extent permitted by applicable Law.

5. Implementation of the Scheme

- 5.1 If Bidco intends to invoke (and, applying the test set out in Rule 13.5 of the Code, the Panel would permit it to so invoke) any of the Conditions, Bidco shall, subject to applicable Law, inform EMIS as soon as is reasonably practicable, providing reasonable details.
- 5.2 Where the Acquisition is being implemented by way of the Scheme:
 - (A) Bidco undertakes to deliver a notice in writing to EMIS on the Business Day immediately prior to the Sanction Hearing, confirming either:
 - (i) the satisfaction or waiver of all Conditions (other than the Scheme Conditions); or
 - (ii) its intention to invoke one or more Conditions (if permitted by the Panel) and providing reasonable details of the event which has occurred, or circumstances which have arisen, which Bidco reasonably considers entitles it to invoke such Condition or treat it as unsatisfied or incapable of satisfaction, and the reasons why Bidco considers such event or circumstance sufficiently material for the Panel to permit it to invoke such Condition; and
 - (B) where Bidco confirms the satisfaction or waiver of all Conditions (other than the Scheme Conditions) in accordance with clause 5.2(A)(i):
 - Bidco agrees that EMIS shall be permitted to take the necessary steps to procure that the Sanction Hearing is duly held as soon as reasonably practicable thereafter;
 - (ii) Bidco agrees to instruct counsel to appear on its behalf at the Sanction Hearing and undertake to the Court to be bound by the terms of the Scheme and consent to the implementation of the Scheme; and
 - (iii) Bidco shall co-operate in relation to, and provide such documentation or information as may reasonably be required by EMIS's counsel or the Court in relation to, such undertaking.

6. Switching to an Offer

- 6.1 The parties intend that the Acquisition will be implemented by way of the Scheme. However, Bidco shall be entitled, with the consent of the Panel (if required), to elect at any time to implement the Acquisition by way of an Offer, rather than a Scheme (such election being a "**Switch**") if:
 - (A) EMIS provides its prior written consent;

- (B) a Competing Proposal is announced by any third party or any member of the EMIS Group (or an announcement in respect of a Competing Proposal is made by the Takeover Panel);
- (C) an EMIS Board Adverse Recommendation Changes occurs;
- (D) either:
 - the EMIS Court Meeting is not held on or before the 22nd day after the expected date of such meeting as set out in the Scheme Document (or such later date as may be agreed in writing between Bidco and EMIS with the consent of the Panel and the approval of the Court (if such approval is required)); or
 - (ii) the EMIS General Meeting is not held on or before the 22nd day after the expected date of such meeting as set out in the Scheme Document (or such later date as may be agreed in writing between Bidco and EMIS with the consent of the Panel and the approval of the Court (if such approval is required)); or
- (E) (i) any person (together with any person acting in concert with it) becomes interested in EMIS Shares equivalent to 15 per cent. or more of the entire issued share capital of EMIS and (ii) Bidco has not received an irrevocable undertaking to vote in favour of the EMIS Resolutions relating to the Acquisition at the EMIS Court Meeting and the EMIS General Meeting from such person within three (3) Business Days of a request to provide such an undertaking from Bidco or EMIS (whichever is earlier).
- 6.2 In the event of an Agreed Switch, unless otherwise agreed in writing between Bidco and EMIS or required by the Panel, the parties agree that:
 - (A) the Acceptance Condition shall be set at 90 per cent. of the EMIS Shares to which the Offer relates (or such lesser percentage as may be agreed between EMIS and Bidco in writing after, to the extent necessary, consultation with the Panel, being in any case more than 50 per cent. of the voting rights attaching to the EMIS Shares);
 - (B) Bidco shall not take any action which would cause the Offer not to proceed, to lapse or to be withdrawn, in each case for non-fulfilment of the Acceptance Condition, prior to midnight on the 60th day after publication of the Offer Document (or such later date as is set in accordance with Rule 31.3 of the Code) ("Day 60"), including, without limitation, by publishing an acceptance condition invocation notice (as defined in Rule 31.6 of the Code) or specifying in the Offer Document an unconditional date which is earlier than Day 60, and Bidco shall ensure that the Offer remains open for acceptances until such time;
 - (C) Bidco shall not, without the prior written consent of EMIS, make any acceleration statement (as defined in the Code) unless: (i) all of the Conditions (other than the

Acceptance Condition) have been satisfied or waived (if capable of waiver); (ii) the acceleration statement contains no right for Bidco to set the statement aside (except with the prior written consent of EMIS and/or in the circumstances envisaged by note 2 or 3 to Rule 31.5); and (iii) Bidco undertakes to EMIS not to take any action or step otherwise to set the acceleration statement aside;

- (D) if at any time following the publication of the Offer Document it is reasonably expected that any outstanding Regulatory Condition is not likely to be satisfied or waived (if capable of waiver) prior to the last date permitted under Rule 31.1 of the Code, Bidco shall, before the 30th day after the publication of the Offer Document (or such later day as EMIS may agree), consult with EMIS and the Panel as to whether the offer timetable should be suspended in accordance with Rule 31.4(a) of the Code or, if Day 39 has passed, Day 60 should be extended in accordance with Rule 31.3 of the Code (or, if applicable, further suspended or extended) and, if so, seek the consent of the Panel to such suspension or extension to a date agreed with EMIS and the Panel, provided always that such date shall not be later than the Long Stop Date;
- (E) Bidco shall ensure that, subject to the terms of this Agreement, the Offer is made on the same terms as those set out in the Announcement and the only conditions of the Offer shall be the Conditions (subject to replacing the Scheme Condition with the Acceptance Condition referred to in clause 6.2(A)) unless the parties agree otherwise in writing or with any modification or amendment to such terms and Conditions as may be required by the Panel; and
- (F) Bidco shall keep EMIS informed, on a regular and confidential basis, and in any event, within two Business Days following receipt of a written request from EMIS, of the number of EMIS Shareholders that have validly accepted or withdrawn their acceptance of the Offer, or incorrectly submitted their acceptance or withdrawal, the identity of such shareholders, and the number of EMIS Shares held by such shareholders.
- 6.3 In the event of any Agreed Switch, the parties agree that all provisions of this Agreement relating to the Scheme and the Scheme Document and its implementation shall apply to the Offer, the Offer Document and its implementation *mutatis mutandis*, save as set out in this clause 6.

7. Dividends

- 7.1 The parties agree that EMIS Shareholders will be entitled to receive the Permitted Interim Dividend and the Permitted Final Dividend (in each case, if declared) on the terms and in the circumstances set out in the Announcement and that payment of, and not exceeding, these amounts will not affect or reduce the Consideration in any way.
- 7.2 If, on or after the date of the Announcement, any dividend or other distribution is authorised, declared, made or paid or becomes payable by EMIS (other than, or in excess of, any Permitted Dividends), Bidco shall have the right to reduce the Consideration by the aggregate amount of such dividend or other distribution, in which case the relevant

eligible EMIS Shareholders will be entitled to receive and retain any such dividend or other distribution.

8. EMIS Share Plans

The parties agree that the provisions of Schedule 1 (EMIS Share Plans) with respect to certain employee-related matters shall be implemented in accordance with that Schedule.

9. Directors' and Officers' Liability Insurance

- 9.1 If and to the extent such obligations are permitted by applicable Law, for six (6) years after the Effective Date, Bidco shall procure that the members of the EMIS Group honour and fulfil all their respective obligations (if any) existing at the date of this Agreement to provide all reasonable assistance to the current directors and officers of EMIS to the extent they need to make a claim against the existing EMIS directors' and officers' insurance policy (including any associated run-off cover), in each case with respect to matters existing or occurring at or prior to the Effective Date.
- 9.2 Bidco acknowledges that EMIS may purchase directors' and officers' liability insurance cover for both current and former directors and officers of the EMIS Group, including directors and officers who retire or whose employment is terminated as a result of the Acquisition, for acts and omissions up to and including the Effective Date, in the form of run-off cover for a period of six (6) years following the Effective Date. Such insurance cover shall be with reputable insurers and provide cover, in terms of quantum and scope, substantially equivalent to that provided under the EMIS Group's directors' and officers' liability insurance as at the date of this Agreement.

10. Termination

- 10.1 Subject to clauses 10.2 and 10.3, this Agreement shall terminate with immediate effect and all rights and obligations of the parties under this Agreement shall cease immediately as follows:
 - (A) if agreed in writing between the parties, at any time prior to the Effective Date;
 - (B) if the Announcement is not released via a Regulatory Information Service on the date of this Agreement (unless, prior to that time, the parties have agreed another later date in accordance with clause 2.1, in which case the later date shall apply for the purposes of this clause 10.1(B));
 - (C) upon service of written notice by Bidco to EMIS, if one or more of the following occurs:
 - a Competing Proposal is announced by any third party or any member of the EMIS Group (or an announcement in respect of a Competing Proposal is made by the Takeover Panel), which Competing Proposal is recommended or is intended to be recommended, in whole or in part, by the EMIS Directors;

- (ii) an EMIS Board Adverse Recommendation Change occurs (other than an EMIS Board Adverse Recommendation Change set out in limb (b) of that definition);
- (iii) where the Acquisition is being implemented by way of the Scheme:
 - (a) the EMIS Court Meeting is not held on or before the 22nd day after the expected date of such meeting as set out in the Scheme Document (or such later date as may be agreed in writing between Bidco and EMIS with the consent of the Panel and the approval of the Court (if such approval is required)); or
 - (b) the EMIS General Meeting is not held on or before the 22nd day after the expected date of such meeting as set out in the Scheme Document (or such later date as may be agreed in writing between Bidco and EMIS with the consent of the Panel and the approval of the Court (if such approval is required)); or
- (D) upon service of written notice by Bidco to EMIS prior to the Long Stop Date stating that either:
 - (i) any Condition which has not been waived is (or has become) incapable of satisfaction by the Long Stop Date and, notwithstanding that Bidco has the right to waive such Condition, Bidco will not do so; or
 - (ii) any Condition which is incapable of waiver is incapable of satisfaction by the Long Stop Date,

in each case in circumstances where the invocation of the relevant Condition (or confirmation that the Condition is incapable of satisfaction, as appropriate) is permitted by the Panel;

- (E) upon service of written notice by either party to the other party, if one or more of the following occurs:
 - a Competing Proposal completes, becomes effective or is declared or becomes unconditional in all respects;
 - (ii) if the Scheme (or the Offer, as the case may be) is withdrawn, terminated or lapses in accordance with its terms prior to the Long Stop Date and, where required, with the consent of the Panel (other than where: (a) such lapse or withdrawal is as a result of the exercise of Bidco's right to effect a Switch; or (b) it is otherwise to be followed within five (5) Business Days (or such other period as EMIS and Bidco may agree) by an announcement under Rule 2.7 of the Code made by Bidco or any person acting in concert with Bidco (or deemed to be acting in concert with Bidco) to implement the Acquisition by a different offer or scheme on substantially the same or improved terms); or

- (iii) except following a Switch, if the Scheme is not approved by the Scheme Shareholders at the EMIS Court Meeting and/or the EMIS Shareholders at the EMIS General Meeting, or any of the EMIS Resolutions are not approved at the EMIS General Meeting, or the Court refuses to sanction the Scheme; or
- (iv) unless otherwise agreed by the parties in writing or required by the Panel, if the Effective Date has not occurred by the Long Stop Date; or
- (F) if the Effective Date occurs.
- 10.2 Termination of this Agreement shall be without prejudice to the rights of either party that may have arisen at or prior to termination.
- 10.3 This clause 10 and clause 1, clauses 11 to 21 (inclusive) and clauses 23 to 24 (inclusive) shall survive termination of this Agreement.

11. Takeover Code

- 11.1 Nothing in this Agreement shall in any way limit the parties' obligations under the Code, and any uncontested rulings of the Panel as to the application of the Code in conflict with the terms of this Agreement shall take precedence over such terms of this Agreement.
- 11.2 The parties agree that, if the Panel determines that any provision of this Agreement that requires EMIS to take or not to take any action, whether as a direct obligation or as a condition to any other person's obligation (however expressed), is not permitted by Rule 21.2 of the Code, that provision shall have no effect and shall be disregarded.
- 11.3 Nothing in this Agreement shall oblige EMIS or the EMIS Directors to recommend an Offer or a Scheme proposed by Bidco or any member of the Wider Optum Group.
- 11.4 Without prejudice to the parties' warranties under clause 12, nothing in this Agreement shall be taken to restrict the directors of any member of the Bidco Group or the EMIS Group (respectively) from complying with applicable Law, including but not limited to the Code, the AIM Rules and the rules and regulations of any Relevant Authority.

12. Warranties

- 12.1 Each of the parties warrants to the other on the date of this Agreement that:
 - (A) it has the requisite power and authority to enter into and perform its obligations under this Agreement;
 - (B) this Agreement constitutes legal, valid and binding obligations in accordance with its terms;
 - (C) the execution and delivery of, and performance of its obligations under, this Agreement will not:

- (i) result in any breach of any provision of its constitutional documents;
- (ii) result in a breach of, or constitute a default under, any instrument (which is material in the context of the Acquisition) to which it is a party or by which it is bound; or
- (iii) result in a breach of any order, judgment, or decree of any court or governmental agency to which it is a party or by which it is bound.
- 12.2 No party shall have any claim against the other party pursuant to clause 12.1 for breach of warranty after the Effective Date (without prejudice to any liability for fraudulent misrepresentation or fraudulent misstatement).

13. Notices

- 13.1 A notice under or in connection with this Agreement (a "**Notice**") shall be:
 - (A) in writing;
 - (B) in the English language; and
 - (C) delivered personally or sent by first class post pre-paid recorded delivery (or air mail if overseas) or by email to the party due to receive the Notice at the address specified in clause 13.2 (or to another address specified by that party by not less than seven (7) days' written notice to the other party).
- 13.2 The address referred to in clause 13.1 is:

- 13.3 A party may change its notice details on giving notice to the other party of the change in accordance with clauses 13.1, 13.2 and 13.4.
- 13.4 Unless there is evidence that it was received earlier, a Notice is deemed given:
 - (A) if delivered personally, when left at the address referred to in clause 13.2;
 - (B) if sent by post, except air mail, two (2) Business Days after posting it;
 - (C) if sent by air mail, six (6) Business Days after posting it;
 - (D) if sent by email, when sent, provided that the sender does not receive a notice of non-delivery.
- 13.5 Any Notice given outside of Working Hours shall be deemed to be given at the start of Working Hours on the next Business Day.

14. Remedies and waivers

14.1 No delay or omission by any party to this Agreement in exercising any right, power or remedy provided by applicable Law or under this Agreement shall affect that right, power or remedy or operate as a waiver of it.

- 14.2 The single or partial exercise of any right, power or remedy provided by applicable Law or under this Agreement shall not preclude any other or further exercise of it or the exercise of any other right, power or remedy.
- 14.3 The rights, powers and remedies provided in this Agreement are cumulative and not exclusive of any rights, powers and remedies provided by applicable Law.
- 14.4 Without prejudice to any other rights and remedies which either party may have, each party acknowledges and agrees that damages alone may not be an adequate remedy for any breach by either party of the provisions of this Agreement and the other party shall be entitled to seek the remedies of injunction, specific performance and other equitable remedies, for any threatened or actual breach of any such provision of this Agreement by a party hereto, and no proof of special damages shall be necessary for the enforcement by either party of the rights under this Agreement.
- 14.5 Nothing in this Agreement shall oblige EMIS to pay an amount in damages which the Panel determines would not be permitted by Rule 21.2 of the Code.

15. Variation

15.1 No variation of this Agreement shall be effective unless it is in writing (which for this purpose, does not include email) and signed by or on behalf of each of the parties.

16. Invalidity

- 16.1 If at any time any provision of this Agreement is or becomes illegal, invalid or unenforceable in any respect under the applicable Law of any jurisdiction, that shall not affect or impair:
 - (A) the legality, validity or enforceability in that jurisdiction of any other provision of this Agreement; or
 - (B) the legality, validity or enforceability under the law of any other jurisdiction of that or any other provision of this Agreement,

and if such provision would be valid and enforceable if deleted in whole or in part or reduced in application, such provision shall apply with such deletion or modification as may be necessary to make it valid and enforceable.

17. Entire agreement

17.1 The provisions of this Agreement shall be supplemental to, and shall not prejudice the terms of, the Confidentiality Agreement, each of which shall remain in full force and effect. This Agreement, together with the Confidentiality Agreement, constitutes the whole agreement between the parties in relation to the Acquisition, and supersedes any previous agreement between the parties in relation to the Acquisition.

- 17.2 Except in the case of fraud, each party acknowledges that it is entering into this Agreement in reliance upon only this Agreement and that it is not relying upon any precontractual statement that is not set out in this Agreement.
- 17.3 Except in the case of fraud, no party shall have any right of action (including those in tort or arising under statute) against the other party arising out of or in connection with any pre-contractual statement, except to the extent that it is repeated in this Agreement.
- 17.4 For the purpose of this clause 17, "**pre-contractual statement**" means any draft, agreement, undertaking, representation, warranty, promise, assurance or arrangement of any nature whatsoever, whether or not in writing, relating to the subject matter of this Agreement made or given by any person at any time before the date of this Agreement.

18. Third party rights

The parties do not intend that any term of this Agreement should be enforceable, by virtue of the Contracts (Rights of Third Parties) Act 1999, by any person who is not a party to this Agreement.

19. No partnership

No provision of this Agreement and no action taken by the parties under this Agreement creates a partnership between any of the parties or makes a party the agent of another party for any purpose. A party has no authority or power to bind, to contract in the name of, or to create a liability for another party in any way or for any purpose.

20. Assignment

No party shall be entitled to assign (whether absolutely or by way of security and whether in whole or in part), transfer, mortgage, charge, declare itself a trustee for a third party of, or otherwise dispose of in any manner whatsoever, the benefit of this Agreement (or any part of it) or sub-contract in any manner whatsoever its performance under this Agreement, without the prior written consent of the other party.

21. Costs and expenses

Save as expressly provided otherwise, each party shall pay its own costs and expenses in relation to the negotiation, preparation, execution and implementation of this Agreement and any matter contemplated by it.

22. Further assurance

Each party shall, at the cost of the requesting party, use reasonable endeavours to, or use reasonable endeavours to procure that any relevant third party shall, do, execute and perform all such further deeds, documents, assurances, acts and things as the requesting party may reasonably be required to give effect to this Agreement to the requesting party.

23. Counterparts

- 23.1 This Agreement may be executed in any number of counterparts, and by the parties on separate counterparts, but shall not be effective until each party has executed at least one counterpart. Each counterpart shall constitute an original of this agreement, but all the counterparts shall together constitute but one and the same instrument.
- 23.2 Delivery of an executed counterpart signature page of this Agreement by email attachment (pdf) shall be an effective mode of delivery.

24. Governing law and jurisdiction

- 24.1 This Agreement is to be governed by and construed in accordance with English law. Any matter, claim or dispute arising out of or in connection with this Agreement, whether contractual or non-contractual, is to be governed by and determined in accordance with English law.
- 24.2 Each party irrevocably submits to the exclusive jurisdiction of the courts of England and Wales in respect of any matter, claim or dispute arising out of or in connection with this Agreement, whether contractual or non-contractual.

Schedule 1 EMIS Share Plans

EMIS and Bidco agree that the following arrangements and acknowledgments will, where appropriate and subject to the Acquisition becoming effective in all respects, be implemented with respect to the EMIS Share Plans.

If the Acquisition is effected as an Offer, references to the date on which the Court sanctions the Scheme under section 899 of the Companies Act ("**Court Sanction**") and the Effective Date will be read as if they referred to the date on which the Offer becomes or is declared unconditional in all respects and EMIS and Bidco intend to co-operate in effecting the intention of the arrangements set out in this Schedule 1.

1. Appropriate Proposals

- 1.1 Subject to applicable confidentiality, legal and regulatory requirements, EMIS agrees to co-operate with, and provide such details to, Bidco in relation to the EMIS Share Plans as Bidco may reasonably require in order to make and implement appropriate proposals to the participants of the EMIS Share Plans, in accordance with Rule 15 of the Code, and the provisions of this Schedule 1 (the "**Proposals**").
- 1.2 Bidco and EMIS intend jointly to write to participants in the EMIS Share Plans on or around the same time as the Scheme Document is posted to EMIS Shareholders or such other time as may be agreed between EMIS and Bidco and consented to by the Panel, to inform them of the Proposals, the impact of the Scheme on their outstanding options under the EMIS Share Plans, and the actions they may take in connection with their options as a result of the Scheme. EMIS intends to prepare these communications, in a form to be agreed between EMIS and Bidco.
- 1.2 Further details of the Proposals in relation to each EMIS Share Plan are set out in Section 4 of this Schedule 1.
- 1.3 If the Acquisition is effected by way of a Scheme, EMIS and Bidco agree that shareholder approval will be sought for an amendment to the articles of association of EMIS so that any EMIS Shares issued or transferred from treasury after the time and date specified as the Scheme Record Date in the Scheme Document (or such later time as Bidco and EMIS may agree) pursuant to the exercise of options or vesting of contingent share awards under the EMIS Share Plans will be compulsorily acquired by Bidco on the same terms and for the same consideration as was made available to EMIS Shareholders under the Scheme.
- 1.4 Bidco acknowledges that EMIS may make any submission to the Panel which it deems necessary to implement the arrangements referred to in this Schedule 1, having consulted with Bidco before making such submission, and Bidco agrees to co-operate as soon as possible and in good faith in the making of any such submission.

2. Operation of the EMIS Share Plans

2.1 Bidco acknowledges that where any of the EMIS Share Plans provides for the exercise of a discretion (including in respect of performance conditions and time pro-rating), the

exercise of any such discretion shall be a matter solely for the remuneration committee of the EMIS Board (the "**Remuneration Committee**") exercised in accordance with the rules of the relevant EMIS Share Plan and (where applicable) the EMIS remuneration policy, but in each case, subject to the provisions of this Schedule 1 below (as applicable).

- 2.2 Bidco acknowledges that between the date of this Agreement and the Effective Date, EMIS may satisfy the exercise of any options granted under the LTIP and CSOP (including any Award Dividends as defined in the LTIP) with EMIS Shares held in, or acquired as contemplated by paragraph 3.5 below by, the EMIS EBT (to the extent sufficient) and, thereafter, with newly issued EMIS Shares, subject to the consent of the Panel where applicable.
- 2.3 Bidco acknowledges that EMIS shall continue to operate the SIP as normal until the Effective Date, including in particular, that Partnership Shares (as defined in the SIP) may continue to be purchased by participants and, if applicable, that Free Shares, Matching Shares and/or Dividend Shares (each as defined in the SIP) may continue to be awarded in accordance with the terms of the SIP and any arrangements already entered into with SIP participants.
- 2.4 The estimated number of EMIS Shares to be issued to SIP participants is 3,000 per month. EMIS agrees to procure that any surplus EMIS Shares held by the trustee of the SIP which have not been awarded to SIP participants are applied in making any further awards under the SIP in priority to any other source of EMIS Shares for such purpose, which other source shall include the issue of EMIS Shares, subject to the consent of the Panel where applicable.

For the avoidance of doubt, Bidco further acknowledges that the Remuneration Committee shall assess the performance conditions based on EMIS's current performance, as well as projections of EMIS's future performance, together with any reasonable and objective assumptions required to be made thereto.
- 4.3 Bidco and EMIS acknowledge that based on the information available to the Remuneration Committee and the EMIS Board as at the date of this Agreement, it is the

current assessment of the Remuneration Committee (or the EMIS Board in the case of the underpin) that the performance conditions (where such conditions are applicable) and the underpin (where such an underpin is applicable) that apply to options granted under the LTIP will be satisfied such that those options will vest as follows (before the application of any time pro-rating as described in paragraph 4.4 below): (i) the 2019 Special 4yr Awards will vest as to 90%; (ii) the 2019 Special 5yr Awards will vest as to 80%; and (iii) the 2020 Normal 3yr LTIP Awards, the 2021 Normal 3yr LTIP Awards, the 2022 Normal 3yr LTIP Awards (including those granted following Announcement), the pre-2022 Restricted Share Awards and the 2022 Restricted Share Awards (including those granted following Announcement) will vest as to 100%.

(each a "**Relevant LTIP Participant**") cash settled restricted stock units with a value at grant equal to the aggregate of the value (based on the consideration per EMIS Share payable under the Scheme) of the EMIS Shares underlying any portion of that Relevant LTIP Participant's Relevant LTIP Awards that lapse due to: (A) the application of time prorating under the LTIP rules, as contemplated in paragraph 4.4; and/or (B) the relevant vesting levels referenced in items (i) to (iii) of paragraph 4.3 (each a "**Tracking Vesting Level**") not being achieved (but so that, for clarity, no grant shall be made as a result of this limb (B) in respect of any such underlying portion that would have lapsed even if the relevant Tracking Vesting Level had been achieved) (the "**Transition Awards**").

- 4.8 The grant of each Transition Award will be documented in a separate award agreement made with each Relevant LTIP Participant under the rules of the UnitedHealth Group Incorporated Cash-Settled Long-Term Incentive Program.
- 4.9 Bidco agrees that a Transition Award granted to a Relevant LTIP Participant under paragraph 4.7 above will vest in three equal tranches of one-third on the first, second and third anniversaries of the grant date (each a "Transition Award Vesting Date"), subject in each case to the Relevant LTIP Participant: (i) remaining in employment with a member of the EMIS Group or the Bidco Group, or (ii) if the Relevant LTIP Participant has left employment with a member of the EMIS Group or the Bidco Group before the relevant Transition Award Vesting Date, they have done so by reason of death, permanent longterm disability of the Relevant LTIP Participant or a termination of employment that results in statutory redundancy or severance or separation pay being paid to the Relevant LTIP Participant (as such events are defined within the UnitedHealth Group Incorporated Cash-Settled Long-Term Incentive Program and underlying award agreement). If the Relevant LTIP Participant leaves employment by reason of death or permanent long-term disability, their Transition Award will vest in full as soon as practicable on or after the date of termination of employment. If the termination of employment of the Relevant LTIP Participant results in statutory redundancy or severance or separation pay being paid to the Relevant LTIP Participant, their Transition Award will be subject to reduction by reason of time pro-rating, and will vest and be paid by Bidco or a member of the Bidco Group as soon as practicable on or after the relevant Transition Award Vesting Date or, if the UnitedHealth Compensation Committee so determines within three months after the Relevant LTIP Participant leaving employment, as soon as reasonably practicable after the date of termination of employment if earlier. Any payment on vesting of a Transition Award will be made subject to any required deductions and withholdings for income tax and employee's National Insurance contributions or social security contributions or any other required withholdings in any relevant jurisdiction (but not including any employer's National Insurance contributions or social security contributions). For the avoidance of doubt, the Transition Awards will not be subject to any performance conditions.

Vested Awards

4.10 Participants of the LTIP who hold options will be offered the opportunity to exercise their vested options and acquire the underlying EMIS Shares on Court Sanction.

Tax withholdings

4.11 The consideration payable to the participants of the LTIP under the Acquisition will be paid to them through EMIS's payroll so that the correct amounts of income tax and employee's National Insurance contributions or employee's social security contributions or any other required withholdings can be deducted and accounted for to HM Revenue & Customs or any other relevant tax authority.

The EMIS Company Share Option Plan 2011 and/or the EMIS Company Share Option Plan 2021 (the "CSOP")

4.12 The Proposals to participants in the CSOP will provide for their unvested options to vest up to 100%, subject to: (A) the assessment of performance conditions (if applicable) and;
(B) time pro-rating, in each case, in accordance with the CSOP rules.

- 4.13 Bidco and EMIS acknowledge that the satisfaction of the performance conditions (where such conditions are applicable) that apply to options will be assessed by the Remuneration Committee in good faith on, or shortly prior to, Court Sanction.
- 4.14 Any options that do not vest shall lapse on or shortly after the Effective Date and otherwise in accordance with the CSOP rules.
- 4.15 Bidco acknowledges and agrees (for the purposes of Rule 21 of the Code) that, subject to the consent of the Panel and conditional upon completion of the Acquisition, EMIS shall make a cash compensation payment (the "Cash Payment") to the participants in the CSOP (each a "Relevant CSOP Participant") who: (A) are employees of the EMIS Group on the Effective Date; and (B) hold, immediately prior to Court Sanction, subsisting unvested options granted under the CSOP that, as a result of the application of time prorating in accordance with the CSOP rules, vest only partly (and the element of such an option granted under the CSOP that does not vest, but instead lapses, for that reason, is referred to in this Schedule 1 as the "Unvested CSOP Option"). The Cash Payment will be an amount equal to the aggregate consideration payable under the Scheme for the EMIS Shares subject to the Unvested CSOP Option less the aggregate exercise price that would have been payable in respect of the Unvested CSOP Option. Leavers

- The Bidco Board and the EMIS Board believe that a combination of Optum UK and EMIS would:
 - help the NHS improve patient care and experience by providing clinicians with innovative and improved data and technology tools that could also free up time for clinicians;
 - more effectively support the delivery of key elements of the NHS Long Term Plan; and
 - enable EMIS to grow its business in the UK through accelerated investment in innovation.
- Bidco has agreed that: (a) any Permitted Interim Dividend, being an interim dividend of up to 17.60 pence per EMIS Share and (b) any Permitted Final Dividend, being a final dividend of up to 21.10 pence per EMIS Share, may each be declared and paid to EMIS Shareholders without any reduction in the Consideration.

It is expected that the Scheme Document, containing further information about the Acquisition and notices of the Court Meeting and General Meeting, together with the associated forms of proxy, will be posted to EMIS Shareholders within 28 days of this announcement (or such later time as EMIS, Bidco and the Panel agree) and the Meetings are expected to be held shortly thereafter. The Acquisition is currently expected to complete before the end of 2022, subject to the satisfaction (or, where applicable, waiver) of the Conditions and further terms set out in Appendix 1 to this announcement.

3. **Information relating to Optum UK**

Optum UK is a healthcare software, services and consultancy business. Optum UK and its affiliates have operated in the UK for nearly 20 years. Optum UK is active in the fields of population health management and medicines optimisation where its services and analytics tools help NHS entities (namely Integrated Care Systems and Clinical Commissioning Groups) improve care and clinical outcomes while improving efficiency and cost-effectiveness.

Optum UK is a wholly owned subsidiary of UnitedHealth Group, a health care and well-being company with a mission to help people live healthier lives and help make the health system work better for everyone. UnitedHealth Group employs over 350,000 people globally. Optum UK is part of UnitedHealth Group's Optum business which (among other things) applies technology solutions and data analytics tools to improve healthcare provision.

4. **Information relating to EMIS**

Founded by general practitioners in Egton, North Yorkshire in 1987, EMIS has grown to become a UK leader in connected healthcare software and systems. Its solutions are widely used across a number of major UK healthcare settings, most notably primary care, community care, accident and emergency, and community and hospital pharmacies. EMIS's aim is to join up healthcare through innovative and interoperable technology, helping to deliver better health outcomes to the UK population, supporting longer and healthier lives. EMIS was admitted to AIM in 2010, at a share price of 300p and a market capitalisation of £175 million, and has delivered a strong financial, operational and share price performance in the time since.

EMIS has two core business segments: EMIS Health and EMIS Enterprise. EMIS Health is a supplier of innovative integrated care technology to the NHS, including primary, community, acute and social care. EMIS Enterprise is focused on growth in the business-to-business technology sector within the healthcare market, including management of medicines, partner businesses, patient-facing services, data and analytics, and research and life sciences. EMIS's core products and services include EMIS-X, EMIS Web, ProScript Connect and Patient Access. EMIS employs approximately 1,400 people, primarily in the UK (1,150) and India (250), and reported 2021 revenues of approximately £168 million.

5. **Background to and reasons for the Acquisition**

Background to the Acquisition

Optum, as a longstanding supplier to the NHS, and EMIS customer and partner, has long been aware of EMIS's strong performance in the UK healthcare technology landscape. In evaluating

EMIS, Optum was attracted by the breadth of EMIS's technology solutions and the powerful clinical imperative that informs EMIS's culture, corporate purpose, and product development roadmap: "To be the leading provider of innovative healthcare technology that improves people's lives."

Reasons for the Acquisition

Optum UK believes this combination will help the NHS improve patient care and experience by providing clinicians with innovative and improved data and technology tools to provide better and more effective care to the populations they serve

- The combined offering of Optum UK and EMIS will help NHS clinicians unlock dataled and digital capabilities to better assess risk in populations and target interventions with the goal of improving patient outcomes – and to help clinicians spend more time with their patients.
- Optum UK believes the ability to deliver new products and features to more people in the NHS will accelerate innovation to the benefit of patients and clinicians.
- Optum UK and EMIS both have deep expertise in and a long track record of excellence in ensuring the privacy and security of patient data and will bring this approach, expertise and experience to the NHS more effectively as a combined company. Strict compliance with data security and patient privacy requirements is an absolute priority for both organisations today and this will continue post transaction.

The combination will create a stronger and more capable organisation that can support the delivery of key elements of the NHS Long Term Plan in order to deliver the best possible standard of care to patients in the UK

- The combination of EMIS's innovative primary care records system and other software systems with Optum UK's existing population health management and data analytics capabilities will help clinicians to access integrated software and analytics capabilities directly contributing to the NHS' goal of delivering more personalised and preventative population healthcare.
- The combination of software tools and analytics capability will create new solutions to support the digital transformation of the NHS. Optum UK believes that the combined offering will provide clinicians with the latest approaches to enhance decision making, implement population health management strategies and ultimately treat disease and save lives.
- The combined Optum UK and EMIS will have greater resources to support those delivering the NHS' Long Term Plan, while also bringing smarter, data-driven solutions to the elective recovery plan and other critical challenges facing the NHS.

A combination and accelerated investment in innovation from Optum UK will enable EMIS to grow its business in the UK

• Optum UK is confident that this excellent strategic fit with EMIS will allow it to deliver benefits from accelerated growth and innovation opportunities to patients, clinicians and healthcare systems, in line with the combined vision to help people live healthier lives.

• Optum UK intends to continue EMIS's technology development investments without any material changes to EMIS's long-range plans in accordance with its key areas of interoperability, elite partners, community pharmacy and data analytics.

6. **Recommendation**

The EMIS Directors, who have been so advised by Numis as to the financial terms of the Acquisition, consider the terms of the Acquisition to be fair and reasonable. In providing their advice, Numis has taken into account the commercial assessments of the EMIS Directors. Numis is providing independent financial advice to the EMIS Directors for the purposes of Rule 3 of the Takeover Code.

Accordingly, the EMIS Directors confirm they intend to recommend unanimously that the EMIS Shareholders vote in favour of the Scheme at the Court Meeting and the Resolutions to be proposed at the General Meeting, as the EMIS Directors have irrevocably undertaken to do in respect of their own beneficial holdings which are under their control totalling, in aggregate, 80,451 EMIS Shares, representing approximately 0.127 per cent. of the issued ordinary share capital of EMIS on 16 June 2022 (being the last Business Day before the date of this announcement). Further details of these undertakings are set out in paragraph 1 of Appendix 3 to this announcement.

7. **Background to and reasons for the Recommendation**

In recent years, EMIS has delivered good financial and operating performance while investing in innovative healthcare technology solutions in pursuit of its strategic goals. While the EMIS Directors believe EMIS is well positioned for continued success and that the long-term prospects of the EMIS Group are strong as an independent listed entity, it also recognises that uncertainties exist that are beyond EMIS's control.

After careful consideration of the value and deliverability of the Acquisition and following a period of negotiations with UnitedHealth Group, the EMIS Directors believe that Bidco's offer represents compelling value relative to the standalone prospects of the group. The EMIS Directors believe there is strategic logic in EMIS becoming part of a group with UnitedHealth Group's capabilities, enabling the EMIS Group to accelerate its development. In addition, the EMIS Directors consider that the combined group will be well positioned to serve its customers and partners in the UK's healthcare system, whilst ensuring EMIS remains a strong organisation to support the NHS over the long-term, thereby fulfilling EMIS's purpose to enable better care through technology innovation.

Furthermore, the EMIS Directors note that the Acquisition represents:

- an opportunity for EMIS Shareholders to realise their investment in EMIS in cash in the short term;
- a premium of approximately 49 per cent. to the Closing Price of 1,292 pence per EMIS Share on 16 June 2022 (being the last Business Day before the commencement of the offer period);
- a premium of approximately 46 per cent. to the volume-weighted average price of 1,320 pence per EMIS Share for the three-month period ended 16 June 2022 (being the last Business Day before the commencement of the offer period);

- a premium of approximately 32 per cent. to the all-time high Closing Price of 1,460 pence per EMIS Share in September 2021; and
- an enterprise value of £1,212 million, equivalent to a multiple of 24.8x enterprise value to financial year 2021 adjusted EBITDA.

In considering the recommendation of the Acquisition to EMIS's Shareholders, the EMIS Directors have given due consideration to Bidco's intentions regarding the employees of EMIS as well as Bidco's commitment to continue supporting the NHS in delivering key elements of its Long Term Plan, consistent with EMIS leadership's current plan.

Accordingly, following careful consideration of the above factors, the EMIS Directors intend unanimously to recommend the Acquisition to EMIS Shareholders.

8. Directors, management, employees, pensions, research and development and locations

UK Strategy and Commitment

Optum UK recognises the importance of supporting the NHS in achieving its Long Term Plan to improve the delivery of care for all citizens of the UK. A combination with EMIS will play a critical role, through its leading healthcare technological capabilities, to fulfil this strategy with the companies' complementary cultures and commitment to deliver actionable data insights to clinicians to improve the care of patients in the UK. It is intended that EMIS will operate as a stand-alone operating unit within the UK.

Optum UK recognises the importance of making sure EMIS continues to meet its contractual obligations to the NHS and its enterprise clients. Optum UK intends to ensure the continuity of EMIS's existing business, with plans for EMIS's headquarters to remain in Leeds and no material changes to its existing operations and locations.

Optum UK will continue to handle all health information in accordance with the high standards and protocols required by all applicable laws and regulations, consistent with the existing and past practices of both EMIS and Optum UK. As a diverse healthcare services enterprise, UnitedHealth Group has strong compliance and technology security standards to protect the health information for its enterprise clients and patients. UnitedHealth Group will work closely with EMIS to support EMIS in continuing to further strengthen and develop its robust compliance and data security policies post transaction.

Employees and management

Optum UK believes the complementary talents of the combination of EMIS and Optum UK will enhance the opportunity to become a valued supplier to the NHS in its digital transformation strategy. EMIS's management and its employees will continue to be key to the future success of those businesses in delivering on their current offerings, while striving to develop advanced software that delivers increased coordination across providers in Integrated Care Systems.

Optum UK believes that the core reason for EMIS's commercial success has been its technological innovation through its committed and valuable workforce and except as described in the remainder of this paragraph, it does not intend that, at any time within at least

12 months of completion of the Acquisition, there will be any material change in overall headcount, or conditions of employment, or in the balance of skills and functions of the management and employees of EMIS or of Optum UK's business. There will be some limited operational and administrative restructuring of the combined group required following completion of the Acquisition. In particular, certain corporate and support functions relating to EMIS's status as a listed company will no longer be required on a standalone basis or may be reduced in scope. Optum UK has not yet developed proposals as to how any resulting headcount reductions may be implemented.

The Chair and Non-Executive Directors of EMIS will step down upon completion of the Acquisition.

Existing rights and pensions

Optum UK confirms that, following the Acquisition becoming Effective, the existing contractual and statutory employment rights, including in respect of EMIS's pension schemes (all of which are defined contribution schemes), of the management and employees of EMIS and Optum UK's business will be safeguarded in accordance with applicable law. Optum UK does not intend to make any material change to the conditions of employment of the employees. Optum UK does not intend to make any material changes to the terms and conditions of EMIS's pension schemes, and intends for the employer to continue to make contributions to EMIS's defined contribution schemes in line with the current arrangements.

Management incentive arrangements

Optum UK intends, following completion of the Acquisition, to continue to operate EMIS's current cash-based compensation and incentive programmes. For future share based incentivisation, as EMIS shares will no longer be listed or traded, awards will be made in accordance with the rules and eligibility criteria of the applicable UnitedHealth Group incentive plans. Optum UK expects to put in place certain incentive arrangements for the management of EMIS following completion of the Acquisition. Optum UK has not entered into, and has not had any discussions on proposals to enter into, any form of incentivisation or other arrangements with members of EMIS's management or employees.

Research and development

Optum UK intends to continue EMIS's technology development investments, such as EMIS's successful EMIS-X technology, without any material changes to EMIS's long-term plans in accordance with its key areas of interoperability, elite partners, community pharmacy and data analytics. In addition, Optum UK believes the combination of EMIS's innovative platform and infrastructure with Optum UK's existing data analytics capabilities in the UK will unlock integrated software and analytics capabilities that will help clinicians deliver more personalised, integrated patient care, driven by data, to more patients across the UK.

Locations, headquarters and fixed assets

Optum UK intends to maintain the location of EMIS's headquarters in Leeds and has no plans to make any material changes to the existing operations and locations of EMIS's business.

No material changes are envisaged by Optum UK with respect to the redeployment of EMIS's fixed asset base in the UK.

Trading facilities

EMIS Shares are currently admitted to trading on AIM. As set out in paragraph 15, it is intended that a request will be made to the London Stock Exchange to cancel trading in EMIS Shares on AIM, and to re-register EMIS as a private limited company, to take effect shortly after the Effective Date.

None of the statements in this paragraph 8 is a "post-offer undertaking" for the purposes of Rule 19.5 of the Takeover Code.

9. Irrevocable undertakings and letters of intent

As described above, Bidco has received irrevocable undertakings to vote (or, where applicable, procure voting) in favour of the Scheme at the Court Meeting and the Resolutions to be proposed at the General Meeting (or, in the event that the Acquisition is implemented by an Offer, to accept or procure acceptance of such Offer) from all of the EMIS Directors who hold EMIS Shares, in respect of their own legal and/or beneficial holdings which are under their control, totalling 80,451 EMIS Shares (representing approximately 0.127 per cent. of the existing issued ordinary share capital of EMIS) as at 16 June 2022, being the last Business Day before the date of this announcement), as well as any further EMIS Shares which they may become the legal or beneficial holder of. The undertakings from EMIS Directors will cease to be binding if: (i) Bidco announces, with the consent of the Panel, that it is not proceeding with the Acquisition and no new, revised or replacement offer or scheme is announced by Bidco at the same time; (ii) the Scheme Document is not dispatched to EMIS Shareholders within 28 days (or such longer period as may be agreed between EMIS and the Panel) of this announcement; (iii) the Scheme lapses or is withdrawn in accordance with its terms and no new, revised or replacement takeover offer or scheme is announced by Bidco by such time; (iv) the Scheme has not become Effective by the Long Stop Date (other than in circumstances where Bidco has, prior to such date, elected to exercise its right to proceed by way of an Offer and announced the same in accordance with the requirements of paragraph 8 of Appendix 7 to the Code, and such Offer has not lapsed or been withdrawn); and (v) any competing offer for the entire issued and to be issued share capital of EMIS is declared unconditional or, if proceeding by way of a scheme of arrangement, becomes effective. The undertakings will remain binding in the event that a higher competing offer for EMIS is made.

In addition to the irrevocable undertakings from EMIS Directors described above, Bidco has also received irrevocable undertakings from Katherine Southby, in respect of a total of 31,545 EMIS Shares, and Nicola Boyd, in respect of a total of 4,500 EMIS Shares, to vote in favour of the Scheme at the Court Meeting and the Resolutions to be proposed at the General Meeting (or in the event that the Acquisition is implemented by an Offer, to accept or procure acceptance of such Offer), representing, in aggregate, approximately 0.057 per cent. of the existing issued ordinary share capital of EMIS, as at 16 June 2022 (being the last Business Day before the date of this announcement), as well as any further EMIS Shares which they may become the legal or beneficial holder of.

In addition, each of Octopus Investments Ltd and Evenlode Investment Management Ltd has given to Bidco a non-binding letter of intent to vote in favour of the Scheme (or in the event that the Acquisition is implemented by an Offer, to accept or procure acceptance of such Offer) in respect of, in aggregate, 8,658,205 EMIS Shares. On 16 June 2022 (being the last Business Day before the date of this announcement) those letters of intent together represented approximately 13.676 per cent. of the existing issued share capital of EMIS.

Bidco has therefore received irrevocable undertakings or letters of intent in respect of a total of 8,774,701 EMIS Shares representing, in aggregate, approximately 13.860 per cent. of EMIS's share capital in issue on 16 June 2022 (being the last Business Day before the date of this announcement).

Further details of these irrevocable undertakings (including the circumstances in which they cease to be binding) and letters of intent are set out in Appendix 3 to this announcement.

10. **Financing of the Acquisition**

The Acquisition will be fully funded through UnitedHealth Group's existing cash resources.

Robey Warshaw, in its capacity as the financial adviser to UnitedHealth Group and Bidco, is satisfied that sufficient resources are available to Bidco to enable it to satisfy in full the cash consideration payable to EMIS Shareholders under the terms of the Acquisition.

Further information on the financing of the Acquisition will be set out in the Scheme Document.

11. Offer-related arrangements

Confidentiality Agreement

On 8 April 2022, Optum UK and EMIS entered into a confidentiality agreement in relation to the Acquisition (the "**Confidentiality Agreement**"), pursuant to which, amongst other things, Optum UK gave certain undertakings to: (a) subject to certain exceptions, keep information relating to EMIS and the Acquisition confidential and not to disclose it to third parties; (b) procure that its representatives who receive confidential information keep it confidential; and (c) use such confidential information only in connection with the Acquisition. These confidentiality obligations will remain in force until 8 April 2024.

Co-operation Agreement

On 17 June 2022, Bidco and EMIS entered into a co-operation agreement in relation to the Acquisition (the "**Co-operation Agreement**"), pursuant to which, amongst other things: (a) EMIS and Bidco have agreed to co-operate for the purposes of obtaining certain regulatory clearances; (b) Bidco has agreed to provide EMIS with certain information for the purposes of the Scheme Document and to otherwise assist with the preparation of the Scheme Document; (c) Bidco has agreed to certain provisions if the Scheme should switch to an Offer; and (d) each of EMIS and Bidco has agreed to take certain actions to implement certain proposals in relation to the EMIS Share Plans.

The Co-operation Agreement will terminate if: (i) the parties agree in writing prior to the Effective Date that it shall be terminated; or (ii) amongst other things: (a) the Acquisition is withdrawn or lapses; (b) (at Bidco's election) prior to the Long Stop Date any Condition becomes incapable of satisfaction; (c) (at Bidco's election) the EMIS Directors withdraw their recommendation of the Acquisition; (d) (at Bidco's election) the EMIS Directors recommend or intend to recommend a competing proposal; or (e) (at either party's election) a competing proposal completes, becomes effective or is declared unconditional in all respects; or (f) the Scheme does not become Effective in accordance with its terms by the Long Stop Date.

12. Disclosure of interests in EMIS securities

Except for the irrevocable commitments referred to in paragraph 9 above, as at close of business on 16 June 2022 (being the last practicable date prior to the date of this announcement) none of UnitedHealth Group, Bidco, nor any of their directors, nor, so far as Bidco is aware, any person acting in concert (within the meaning of the Takeover Code) with any of them for the purposes of the Acquisition: (i) had any interest in or right to subscribe for or had borrowed or lent any EMIS Shares or securities convertible or exchangeable into EMIS Shares; (ii) had any short positions in respect of relevant securities of EMIS (whether conditional or absolute and whether in the money or otherwise), including any short position under a derivative, any agreement to sell or any delivery obligation or right to require another person to purchase or take delivery; (iii) has borrowed or lent any relevant securities of EMIS (including, for these purposes, any financial collateral arrangements of the kind referred to in Note 4 on Rule 4.6 of the Takeover Code) save for any borrowed shares which have been either on-lent or resold; or (iv) is a party to any dealing arrangement of the kind referred to in Note 11 on the definition of acting in concert in the Takeover Code in relation to the relevant securities of EMIS.

'Interests in securities' for these purposes and within the meaning of the Takeover Code arise, in summary, when a person has long economic exposure, whether absolute or conditional, to changes in the price of securities (and a person who only has a short position in securities is not treated as interested in those securities). In particular, a person will be treated as having an 'interest' by virtue of the ownership, voting rights or control of securities, or by virtue of any agreement to purchase, option in respect of, or derivative referenced to securities.

13. **EMIS Share Plans**

Participants in the EMIS Share Plans will be contacted regarding the effect of the Acquisition on their rights under the EMIS Share Plans and an appropriate proposal will be made to such participants in due course.

Details of the impact of the Scheme on each of the EMIS Share Plans and the proposals will be set out in the Scheme Document.

14. Scheme process

It is intended that the Acquisition shall be effected by means of a Court-sanctioned scheme of arrangement between EMIS and EMIS Shareholders under Part 26 of the 2006 Act, although Bidco reserves the right for Bidco to implement the Acquisition by means of an Offer (subject to Panel consent and the terms of the Co-operation Agreement).

The purpose of the Scheme is to provide for Bidco to become the holder of the entire issued and to be issued share capital of EMIS. This is to be achieved by the transfer of the EMIS Shares (other than any EMIS Shares held by Bidco or members of the Bidco Group) to Bidco, in consideration for which the EMIS Shareholders shall receive cash consideration on the basis set out in paragraph 2.

The Acquisition is subject to the Conditions and certain further terms referred to in Appendix 1 to this announcement and to the full terms and conditions to be set out in the Scheme Document, and will only become Effective if, among other things, the following events occur on or before the Long Stop Date:

- a resolution to approve the Scheme is passed by a majority in number of the Scheme Shareholders present and voting (and entitled to vote) at the Court Meeting, either in person or by proxy, representing 75 per cent. or more in value of each class of the Scheme Shares held by those Scheme Shareholders;
- the Resolutions required to approve and implement the Scheme being duly passed by EMIS Shareholders representing the requisite majority or majorities of votes cast at the General Meeting (or any adjournment thereof);
- following the Court Meeting and General Meeting, the Scheme is sanctioned by the Court (without modification, or with modification on terms agreed by Bidco and EMIS); and
- following such sanction, a copy of the Court Order is delivered to the Registrar of Companies.

The Scheme will lapse if, among other things:

- the Court Meeting and the General Meeting are not held on or before the 22nd day after the expected date of such meetings, which will be set out in the Scheme Document in due course (or such later date as may be agreed between Bidco and EMIS with the consent of the Panel and, if required, the Court);
- the Sanction Hearing to approve the Scheme is not held on or before the 22nd day after the expected date of such hearing, which will be set out in the Scheme Document in due course (or such later date as may be agreed between Bidco and EMIS with the consent of the Panel and, if required, the Court); or
- the Scheme does not become Effective on or before the Long Stop Date,

provided, however, that the deadlines for the Court Meeting, the General Meeting and the Sanction Hearing as set out above may be waived by Bidco and the deadline for the Scheme to become Effective may be extended by agreement between EMIS and Bidco with the consent of the Panel and, if required, the Court.

Once the necessary approvals from EMIS Shareholders have been obtained and the other Conditions have been satisfied or (where applicable) waived and the Scheme has been approved by the Court, the Scheme will become Effective upon delivery of the Court Order to the Registrar of Companies. Subject to the satisfaction (or, where applicable, waiver) of the Conditions and the further terms set out in Appendix 1, the Scheme is expected to become Effective before the end of 2022.

Upon the Scheme becoming Effective: (i) it will be binding on all Scheme Shareholders, irrespective of whether or not they attended or voted at the Court Meeting or the General Meeting (and if they attended and voted, whether or not they voted in favour); and (ii) entitlements to EMIS Shares held within the CREST system will be cancelled and such entitlements rematerialised; and (iii) share certificates in respect of EMIS Shares will cease to be valid. The Consideration will be dispatched to EMIS Shareholders no later than 14 days after the Effective Date.

Any EMIS Shares issued before the Scheme Record Time will be subject to the terms of the Scheme. The Resolution(s) to be proposed at the General Meeting will, amongst other matters,

provide that the Articles be amended to incorporate provisions requiring any EMIS Shares issued after the Scheme Record Time (other than to Bidco and/or their nominees) to be automatically transferred to Bidco (and, where applicable, for Consideration to be paid to the original recipient of the EMIS Shares so issued) on the same terms as the Acquisition (other than terms as to timings and formalities). The provisions of the Articles (as amended) will avoid any person (other than Bidco and their nominees) holding shares in the capital of EMIS after the Effective Date.

Bidco reserves the right to elect to implement the Acquisition by way of an Offer as an alternative to the Scheme (subject to the Panel's consent and the terms of the Co-operation Agreement). In such event, the Acquisition will be implemented on the same terms (subject to appropriate amendments including (without limitation) the inclusion of an acceptance condition which, unless otherwise agreed in writing between Bidco and EMIS or otherwise required by the Panel, will be set at 90 per cent. (or such lesser percentage as may be agreed between EMIS and Bidco in writing after, to the extent necessary, consultation with the Panel, being in any case more than 50 per cent. of the voting rights attaching to the EMIS Shares) of the shares to which the Acquisition relates and those required by, or deemed appropriate by, Bidco under applicable law, so far as applicable) as those which would apply to the Scheme. Further, if sufficient acceptances of such Offer are received and/or sufficient EMIS Shares are otherwise acquired, it is the intention of Bidco to apply the provisions of the 2006 Act to acquire compulsorily any outstanding EMIS Shares to which such Offer relates.

Further details of the Scheme, including expected times and dates for each of the Court Meeting, the General Meeting and the Sanction Hearing, together with notices of the Court Meeting and the General Meeting, will be set out in the Scheme Document, which will be published as soon as reasonably practicable after the date of this announcement and in any event within 28 days of this announcement. The Scheme will be governed by the laws of England and Wales and will be subject to the jurisdiction of the courts of England and Wales.

15. **Cancellation of trading and re-registration**

It is intended that the London Stock Exchange will be requested to cancel trading in EMIS Shares on AIM shortly after the Effective Date.

 - (iii) the Secretary of State making a final order pursuant to section 26(1)(a) of the NS&I Act in relation to the Acquisition, save to the extent that such an order prohibits the Acquisition.

General Conditions

4. In addition, subject as stated in Part B below and to the requirements of the Panel, Bidco and EMIS have agreed that the Acquisition will be conditional upon the following Conditions and, accordingly, the Court Order will not be delivered to the Registrar of Companies unless the following Conditions (as amended if appropriate) have been satisfied or, where relevant, waived:

Official authorisations, regulatory clearances and third party clearances

- (a) excluding any briefing paper, notification and/or filing required for the purposes of the relevant confirmation, consent and/or order referred to in Conditions 3(a) and 3(b) (to which only Conditions 3(a) and 3(b) shall apply, as applicable), the waiver (or non-exercise within any applicable time limits) by any relevant government or governmental, quasi-governmental, supranational, statutory, regulatory, environmental or investigative body, court, trade agency, association, institution, any entity owned or controlled by any relevant government or state, or any other body or person whatsoever in any jurisdiction (each a "Third Party") of any termination right, right of preemption, first refusal or similar right (which is material in the context of the Wider EMIS Group taken as a whole) arising as a result of or in connection with the Acquisition including, without limitation, its implementation or the proposed direct or indirect acquisition of any shares or other securities in, or control or management of, EMIS or any member of the Wider EMIS Group taken as the Wider EMIS Group by Bidco or any member of the Wider Optum Group;
- (b) excluding any briefing paper, notification and/or filing required for the purposes of the relevant confirmation, consent and/or order referred to in Conditions 3(a) and 3(b) (to which only Conditions 3(a) and 3(b) shall apply, as applicable), all material filings or applications which are necessary in connection with the Acquisition having been made and all statutory or regulatory obligations in any jurisdiction having been complied with in connection with the Acquisition or the acquisition by any member of the Wider Optum Group of any shares or other securities in, or control of, EMIS and all Authorisations reasonably deemed necessary or appropriate by Bidco or any member of the Wider Optum Group for or in respect of the Acquisition including without limitation, its implementation or (except pursuant to Chapter 3 of Part 28 of the 2006 Act) the proposed acquisition of any shares or other securities in, or control of, EMIS by any member of the Wider Optum Group having been obtained in terms and in a form reasonably satisfactory to Bidco from all appropriate Third Parties or persons with whom any member of the Wider EMIS Group has entered into contractual arrangements and all such Authorisations necessary or appropriate to carry on the business of any member of the Wider EMIS Group remaining in full force and effect and all filings necessary for such purpose have been made and there being no notice or intimation of any intention to revoke or not to renew any of the same at the time at which the Acquisition becomes otherwise unconditional and all necessary statutory or regulatory obligations in any jurisdiction having been complied with;
- (c) excluding any briefing paper, notification and/or filing required for the purposes of the relevant confirmation, consent and/or order referred to in Conditions 3(a) and 3(b) (to which only Conditions 3(a) and 3(b) shall apply, as applicable), no Third Party having decided to take, institute, implement or threaten (and in each case, not having withdrawn the same) any action, proceeding, suit, investigation, enquiry or reference or enacted, made or proposed (and in each case, not having withdrawn the same) any statute, regulation, decision or order, or change to published practice or having taken any other steps which would or might be expected to:
 - (i) require, prevent or delay the divestiture, or alter the terms envisaged for any proposed divestiture by any member of the Wider Optum Group or any member of the Wider EMIS Group of all or any portion of their respective businesses, assets or property or impose any limitation on the ability of any of them to

conduct their respective businesses (or any of them) or to own any of their respective assets or properties or any part thereof;

- (ii) require, prevent or delay the divestiture by any member of the Wider Optum Group of any shares or other securities in EMIS or any member of the Wider EMIS Group;
- (iii) impose any limitation on, or result in a delay in, the ability of any member of the Wider Optum Group directly or indirectly to acquire or to hold or to exercise effectively any rights of ownership in respect of shares or loans or securities convertible into shares or any other securities (or the equivalent) in any member of the Wider EMIS Group or the Wider Optum Group or to exercise management control over any such member;
- (iv) make the Scheme or the Acquisition or, in each case, its implementation or the acquisition or proposed acquisition by Bidco or any member of the Wider Optum Group of any shares or other securities in, or control of EMIS or any member of the Wider EMIS Group, void, illegal, and/or unenforceable under the laws of any jurisdiction, or otherwise, directly or indirectly, restrain, restrict, prohibit, delay or otherwise interfere with the same, or impose additional conditions or obligations with respect thereto, or otherwise challenge or interfere therewith;
- (v) except pursuant to the implementation of the Acquisition or, if applicable, sections 974 to 991 of the 2006 Act, require any member of the Wider Optum Group or the Wider EMIS Group to offer to acquire any shares or other securities (or the equivalent) or interest in any member of the Wider EMIS Group or the Wider Optum Group owned by any third party;
- (vi) impose any limitation on the ability of any member of the Wider Optum Group or the Wider EMIS Group to conduct, integrate or co-ordinate its business, or any part of it, with the businesses of any other member of the Wider Optum Group or the Wider EMIS Group;
- (vii) result in any member of the Wider EMIS Group ceasing to be able to carry on business under any name under which it presently does so; or
- (viii) otherwise adversely affect the business, assets, profits, financial or trading position or prospects of any member of the Wider Optum Group or of any member of the Wider EMIS Group,

and all applicable waiting and other time periods (including any extensions of such waiting and other time periods) during which any such Third Party could institute, implement or threaten any action, proceeding, suit, investigation, enquiry or reference or any other step under the laws of any jurisdiction in respect of the Acquisition or the acquisition or proposed acquisition of any EMIS Shares having expired, lapsed or been terminated;

Certain matters arising as a result of any arrangement, agreement, etc.

- (d) except as Disclosed, there being no provision of any arrangement, agreement, licence, permit, franchise, lease or other instrument to which any member of the Wider EMIS Group is a party or by or to which any such member or any of its assets is or may be bound, entitled or be subject or any event or circumstance which, as a consequence of the Acquisition or the proposed acquisition by any member of the Wider Optum Group of any shares or other securities in EMIS or because of a change in the control or management of any member of the Wider EMIS Group or otherwise, could or might reasonably be expected to result in any of the following to an extent which is material and adverse in the context of the Wider EMIS Group, or the Wider Optum Group, in either case, taken as a whole:
 - (i) any monies borrowed by, any other indebtedness or liabilities, actual or contingent of, or any grant available to, any member of the Wider EMIS Group being or becoming repayable, or capable of being declared repayable, immediately or prior to its or their stated maturity date or repayment date, or the ability of any such member to borrow monies or incur any indebtedness being withdrawn or inhibited or being capable of becoming or being withdrawn or inhibited;

- (vii) the value of, or the financial or trading position or prospects of any member of the Wider EMIS Group being prejudiced or adversely affected; or
- (viii) the creation or acceleration of any liability (actual or contingent) by any member of the Wider EMIS Group other than trade creditors or other liabilities incurred in the ordinary course of business,

and, no event having occurred which, under any provision of any agreement, arrangement, licence, permit or other instrument to which any member of the Wider EMIS Group is a party or by or to which any such member or any of its assets are bound, entitled or subject, could or might reasonably be expected to result in any of the events or circumstances as are referred to in sub-paragraphs (i) to (vii) of this Condition;

- (e) except as Disclosed and contemplated by this announcement, no member of the Wider EMIS Group having since 31 December 2021:
 - (i) save as between EMIS and its wholly-owned subsidiaries or between such wholly-owned subsidiaries and save for the issue or transfer out of treasury of EMIS Shares on or in connection with the exercise of options, the vesting and/or settlement of awards granted in the ordinary course under the EMIS Share Plans, issued or agreed to issue or authorised or proposed or announced its intention to authorise or propose the issue of additional shares of any class, or securities or securities convertible into, or exchangeable for, or rights, warrants or options to subscribe for or acquire, any such shares or convertible securities or transferred or sold or agreed to transfer or sell or authorised or proposed the transfer or sale of EMIS Shares out of treasury;

 - (ii) any member of the Wider EMIS Group, or any of their respective directors, officers or senior employees, is debarred or otherwise rendered ineligible to bid for, be awarded or perform any contract or business for or with any government, governmental authority or agency or public body or found to have violated any applicable law, rule or regulation concerning government contracting or public procurement;
 - (iii) any past or present member, director, officer or employee of the Wider EMIS Group, or any other person for whom any such person may be liable or responsible, is or has engaged in any conduct which would violate applicable sanctions or dealt with, made any investments in, made any funds or assets available to or received any funds or assets from:
 - (a) any government, entity or individual in respect of which US, UK or European Union persons, or persons operating in those territories, are prohibited from engaging in activities or doing business, or from receiving or making available funds or economic resources, by US, UK, United Nations or European Union laws or regulations, including the sanctions administered by the United States Office of Foreign Assets Control, or any department of Her Majesty's Government; or

Part B: Further terms of the Acquisition

- 1. Conditions 2(a), 2(b), 3(a), 3(b), and 4(a) to (j) (inclusive) set out in Part A of this Appendix must each be fulfilled, determined by Bidco to be or to remain satisfied or (if capable of waiver) be waived by Bidco prior to the commencement of the Sanction Hearing, failing which the Scheme will lapse.
- 2. Notwithstanding the paragraph above, subject to the requirements of the Panel and the Takeover Code, Bidco reserves the right in its sole discretion to waive:
 - (a) the deadline set out in Condition 1 of Part A of this Appendix 1, and any of the deadlines set out in Condition 2 of Part A of this Appendix 1 for the timing of the Court Meeting, General Meeting and the Sanction Hearing. If any such deadline is not met, Bidco shall make an announcement by 8.00 a.m. on the Business Day following such deadline confirming whether it has invoked or waived the relevant Condition or agreed with EMIS to extend the deadline in relation to the relevant Condition; and
 - (b) in whole or in part, all or any of Conditions 3 and/or 4 listed in Part A of this Appendix above.
- 3. Bidco shall be under no obligation to waive or treat as satisfied any of the Conditions that it is entitled (with the consent of the Panel and subject to the requirements of the Takeover Code) to invoke, by a date earlier than the latest date specified above for the fulfilment or waiver thereof, notwithstanding that the other Conditions may at such earlier date have been waived or fulfilled and that there are at such earlier date no circumstances indicating that any of such Conditions may not be capable of fulfilment.

- 4. If Bidco is required by the Panel to make an offer for EMIS Shares under the provisions of Rule 9 of the Takeover Code, Bidco may make such alterations to any of the above Conditions and terms of the Acquisition as are necessary to comply with the provisions of that Rule.
- 5. Under Rule 13.5(a) of the Takeover Code, Bidco may only invoke a Condition so as to cause the Acquisition not to proceed, to lapse or to be withdrawn with the consent of the Panel. The Panel will normally only give its consent if the circumstances which give rise to the right to invoke the Condition are of material significance to Bidco in the context of the Acquisition. This will be judged by reference to the facts of each case at the time that the relevant circumstances arise. Conditions 1, 2(a), 2(b) and 2(c) and, if applicable, any acceptance condition if the Acquisition is implemented by means of an Offer, are not subject to this provision of the Takeover Code.
- 6. Any Condition that is subject to Rule 13.5(a) of the Takeover Code may be waived by Bidco.
- 7. Bidco reserves the right to elect to implement the Acquisition by way of an Offer as an alternative to the Scheme (subject to the Panel's consent and the terms of the Cooperation Agreement). In such event, the Acquisition will be implemented on the same terms (subject to appropriate amendments including (without limitation) the inclusion of an acceptance condition which, unless otherwise agreed in writing between Bidco and EMIS or otherwise required by the Panel, will be set at 90 per cent. (or such lesser percentage as may be agreed between EMIS and Bidco in writing after, to the extent necessary, consultation with the Panel, being in any case more than 50 per cent. of the voting rights attaching to the EMIS Shares) of shares to which the Acquisition relates and those required by, or deemed appropriate by, Bidco under applicable law, so far as applicable) as those which would apply to the Scheme. Further, if sufficient acceptances of such Offer are received and/or sufficient EMIS Shares are otherwise acquired, it is the intention of Bidco to apply the provisions of the 2006 Act to acquire compulsorily any outstanding EMIS Shares to which such Offer relates.
- 8. The Acquisition will be governed by the laws of England and Wales and be subject to the jurisdiction of the English courts and to the Conditions set out above. The Scheme will be subject to the applicable requirements of the Takeover Code, the Panel, the London Stock Exchange, the AIM Rules and the Registrar of Companies.
- 9. Each of the Conditions shall be regarded as a separate Condition and shall not be limited by reference to any other Condition.
- 10. The EMIS Shares which will be acquired under the Acquisition will be acquired with full title guarantee, fully paid and free from all liens, equities, charges, encumbrances, options, rights of pre-emption and any other third party rights and interests of any nature and together with all rights now or hereafter attaching or accruing to them, including voting rights and the right to receive and retain in full all dividends and other distributions (if any) declared, made or paid, or any other return of value (whether by reduction of share capital or share premium account or otherwise) made on or after the Effective Date (save for any Permitted Dividends).
- 11. If, on or after the date of this announcement and prior to the Effective Date, any dividend, distribution or other return of value (excluding any Permitted Dividends) is

proposed, declared, paid or made or becomes payable by EMIS in respect of the EMIS Shares, Bidco reserves the right (without prejudice to any right of Bidco, with the consent of the Panel, to invoke Condition 4(e)(ii) of Part A of this Appendix 1) to reduce the Consideration to reflect the aggregate amount of such dividend, distribution or other return of value. In such circumstances, EMIS Shareholders would be entitled to receive and retain any such dividend, distribution or other return of value declared, made or paid.

If and to the extent that any such dividend, distribution or other return of value is paid or made in respect of the EMIS Shares prior to the Effective Date, and Bidco exercises its rights under this paragraph 11 to reduce the Consideration, any reference in this announcement to the Consideration shall be deemed to be a reference to the Consideration as so reduced.

If the Effective Date occurs prior to 7 October 2022, there will be no Permitted Interim Dividend and no equivalent payment will be made to EMIS Shareholders by Bidco. 
